Workshop materials are for only those in attendance.

3. The Guild will be responsible for round trip travel expenses from Saginaw, MI (MBS Airport) to _____ (please list preferred airport). Airline tickets are normally purchased about six weeks before the event. The guild is responsible for any nonrefundable airline ticket expenses, except when cancellation is by Beth.

For venues up to 300 miles away Beth often chooses to drive. Mileage is reimbursed at the IRS rate at the time of the event.

4. The Guild will be responsible for providing room and board. Hotel accommodations are requested.

5. A member of the Guild will be made available to assist in the sales of books and patterns to guild members following the lecture. A table will be set up to accommodate this activity, including a place for Beth to autograph any products as requested. A donation of products will be made to the guild library. No percentage of sales will be offered.

All fees are to be paid at the time of service, before the close of the final event. An invoice covering all expenses except the fees for additional students will be emailed approximately one week before the event.

A signed copy of this document must be part of any agreement between Beth Ferrier and your group. Please fill in ALL requested information, sign and return to Applewood Farm Publications within two weeks of the initial request. No date is considered firm without a signed contract.
